NOW THEREFORE,

In consideration of the foregoing premises and the covenants and obligations outlined in this MOU, the parties hereby agree as follows.

ROLES AND RESPONSIBILITIES:

COLLEGE:

- COLLEGE has B. TECH students of civil engineering stream in their campus and wish to impart software knowledge to their students, they shall announce SKP as their preferred software skill provider.
- 2. The college shall arrange communication with faculty and also schedule seminars andskill development programs for students on their campus.
- 3. The college will provide the infrastructure required (like computer systems, projectors, electricity, etc.) in computer labs at its campus for software training.
- The college will have the right to collect fees from the students for the duration of courses in campus. The fees will be mutually agreed by the college and SKP.
- College must support to ensure, all students who have signed up for the class, attend the training programs scheduled for them.

SKP:

- 1. The SKP shall plan the skill modules in consultation with the college.
- The SKP shall announce and inform through its own, the schedule of the skill modules it plans to offer in the academic year concerned for the information of the prospective students and it shall accept the students as admitted by the college for skill training.
- 3. The SKP shall register students for the skill modules.
- The SKP will be entitled to the fees as mutually decided by the college and SKP for the course being conducted by the SKP.
- The SKP will conduct appropriate training sessions for the vocational/skill portion of the vocational education programs to complete the vocational/skill portion within the given period/semester.
- SKP will provide feedback from students regarding software training after a gap of 15 daysbefore after start of training.
- 7. SKP will provide a Single Copy of the Manual of the training (MENTIONED in point 7) in the form of a Hard Copy and a SOFT COPY has to be submitted to HOD for checking of contents before the start of training.
- The SKP will also arrange a field/site visit to the project site during the period of the training, but the cost of transportation will be borne by the College and the responsibility of the students.
- 9. The college will ensure maximum students by motivation and awareness with a minimum target of about 15 students to register for the in-house training with the SKP.
- 10. The SKP will provide practice sessions based on the ongoing consultancy projects undertaken by the SKP to provide a better understanding of the concepts.
- The SKP will Provide 5 Days of Faculty Development Program (twice a year) for faculty in the College.
- The SKP will Provide a paid Internship Program for those students who clear the interview process.
- 13. The SKP will arrange a Guest Lecture (at least two per year) at the time of college training.
- 14. The college will collect the full fee from the students availing training classes and transfer the total amount to the SKP in two installments after deducting the TDS & and College Share.
